## CCUSBC 18th ANNUAL OPEN CHAMPIONSHIP TOURNAMENT RULES

1. ELIGIBILITY: Tournament is open to all persons sanctioned through CCUSBC. CCUSBC Memberships will not be sold at the tournament site. You must present your membership card at check-in.
2. ENTRIES: A bowler may enter the Team Event twice, subject to the following:
A. Participants bowling in 2 Team Events, 1 Doubles, and 1 Singles; if bowling two team events, they must be bowled on different squads.
B. In order to place more than once in the prize list for team position standings, at least two (2) players in the team lineup must be different. (USBC Rule 315b)
C. To be eligible for scratch team event or scratch doubles event all team members must pay appropriate scratch fees.
D. A bowler's first appearance in each event counts towards the all-events total. (USBC Rule 315d)

## 3. COPPER COUNTIES LEAGUE AVERAGES:

A. USBC Rule 319a, 319b, 319c and 319e apply. Challenge League averages will be adjusted per USBC Average Chart for those who only bowl in a Challenge League, all others will use their average in a Standard League for this tournament.
B. USBC Rule 319a2 (10 pin rule) applies: When the previous Season's average is used, and at the time of bowling an entrant has a current average for 21 or more games that is 10 pins or more higher than the prior season's CCUSBC's Association book average, then CCUSBC's Association League current average must be used.
C. Participants shall use their highest 2022-2023 CCUSBC Book Average based on a minimum of 21 games. If no 2022-2023 CCUSBC book average is available, participants will use their highest CCUSBC current average based on 21 or more games. All others shall be assigned an average of 230 .
D. If a bowler was required to switch his/her bowling hand due to injury or medical requirement, the bowler must request from USBC at least one week prior to competition in accordance with USBC rule 4 e .
E. Handicap shall be based on 90 percent of the difference between the entrants average and 230 .
F. REPORTING AN INCORRECT AVERAGE MAY SUBJECT THE ENTRANT TO DISQUALIFICATION.
4. PRIZES: Prizes will be awarded at a ratio of 1:5 entries in each event except for the optional events. All optional events will be awarded at a ratio of 1:8 entries. Prizes will be awarded after verification of averages. Checks are expected to be mailed within 10 business days upon completion of the competition.
5. SUBSTITUTES: Substitutes shall be allowed for just cause. Verification of a subs average must be in the possession of the Tournament Director one-half hour prior to the scheduled bowling time, if possible. A Substitute shall not be required to reimburse the original entrant with any entry fee. Nor shall they be expected to give the original entrant any prize money or award they may win. Optional All Events entry fee may be transferred to a substituting bowler provided the original bowler has not competed in any event prior to the substitution.
6. REPORT TIME: Bowlers will report to the check-in table 30 minutes prior to their scheduled squad time. The team captain may check in their team if all members are present. USBC membership must be verified at check-in.
7. APPEALS: The decision of the Tournament Director shall be final unless an appeal is made in accordance with USBC Rule 329. PROTESTS MUST BE FILED IN WRITING WITHIN 24 HOURS.
8. PAYMENT: Personal checks returned for non-payment will be assessed a $\$ 40.00$ service charge.
9. ENTRY CLOSING DATES: Entries must be postmarked on or before MIDNIGHT, MARCH 16, 2024.
10. CONTACT/MANAGEMENT: Tournament Director for this tournament is the Association Manager, Missy Bosley ccusbcassociationmanager@gmail.com . She has supervisory control of all technical parts of the operation of the tournament in accordance with USBC Rule 303. Anything not covered in these rules will be governed by USBC rules.
11. DRESS CODE: Participants must wear appropriate bowling attire. Participants are required to wear a shirt with a polo, sash or butterfly collar and casual slacks, trousers or jeans that are neat and in good condition; cutoffs, in any fashion, are not allowed. Collarless bowling jerseys will be permitted. Shorts, culottes, skorts, and skirts are permitted as long as they are the appropriate length (length is beyond the fingertips when their arms are extended down their sides). Other examples of prohibited attire include, but are not limited to, hats, tank tops, halter tops, bare midriffs, spaghetti- strap tops and sweat pants. The alteration of any prohibited clothing by means of embroidery, logos, stick-on patches or other means does not alter the definition of said items to make them acceptable. Any bowler requesting a dress code exception for medical or other reason must do so in writing to the tournament manager. Participants who are deemed to not meet the standards of the dress code will be afforded the opportunity to secure acceptable attire or bowl at an alternate time with compliant dress. The dress code will be interpreted by the tournament directors, and their decision is final. No electronics allowed during competition. NO REFUNDS FOR DRESS CODE VIOLATIONS WILL BE ALLOWED.
