CCUSBC 13th ANNUAL MEN'S TOURNAMENT RULES

- 1. ELIGIBILITY:** Tournament is open to all Men sanctioned through USBC. CCUSBC local memberships (\$10) are required for non-members.
- 2. ENTRIES:** A bowler may enter the Singles and Doubles once and Team Event twice, subject to the following:
 - A. Participants bowling in 2 Team Events; at least two (2) players must be different and they must be bowled on different squads. (USBC Rule 315b)
 - B. To be eligible for scratch team event or scratch doubles event all team members in that event must pay appropriate scratch fees
 - C. A bowler's first appearance in each event counts towards the all-events total. (USBC Rule 315d)
- 3. AVERAGE DETERMINATION:**
 - A. USBC Rule 319a, 319b, 319c and 319e will apply.
 - B. USBC Rule 319a2 (10 pin rule) applies: When the previous Season's average is used, and at the time of bowling an entrant has a current average for 21 or more games that is 10 pins or more higher than the prior season's USBC book average, then League current verified average must be used.
 - C. Participants shall use their highest 2025-2026 USBC Book Average based on a minimum of 21 games. If no 2025-2026 USBC book average is available, participants will use their highest USBC VARIFIED 2026-2027 average based on 21 or more games. All others shall be assigned an average of 230.
- 4. PRIZES:** Prizes will be awarded at a ratio of 1:5 entries in each event except for the optional events. All optional events will be awarded at a ratio of 1:8 entries. Prizes will be awarded after verification of averages. Checks are expected to be mailed within 14 business days upon completion of the competition.
- 5. SUBSTITUTES:** Substitutes shall be allowed for just cause. Verification of a subs average must be in the possession of the Tournament Director one-half hour prior to the scheduled bowling time, if possible. A Substitute shall not be required to reimburse the original entrant with any entry fee. Nor shall he be expected to give the original entrant any prize money or award he may win. Optional All Events entry fee may be transferred to a substituting bowler provided the original bowler has not competed in any event prior to the substitution.
- 6. REPORT TIME:** Bowlers will report to the check-in table 30 minutes prior to their scheduled squad time. The team captain may check in his team if all members are present. **USBC membership must be verified at check-in.** Please use your mobile phone to show your current membership on www.bowl.com.
- 7. APPEALS:** The decision of the Tournament Director shall be final unless an appeal is made in accordance with USBC Rule 329. **PROTESTS MUST BE FILED IN WRITING WITHIN 24 HOURS.**
- 8. REFUNDS:** No tournament fees will be returned after the start of the tournament except at the discretion of the Tournament Director.
- 9. PAYMENT: NO CASH WILL BE ACCEPTED FOR ENTRY FEES, PERSONAL, CASHIERS CHECKS OR MONEY ORDERS ONLY. PERSONAL checks returned for non-payment will be assessed a \$40.00 service charge, and entry WILL NOT be entered until funds have been confirmed.**
- 10. ENTRY CLOSING DATES:** Entries must be postmarked on or before **MIDNIGHT, OCTOBER 31, 2026.**
- 11. CONTACT/MANAGEMENT:** Tournament Director for this tournament is Association Manager, Bev Pederson ccusbcassociationmanager@gmail.com . She has supervisory control of all technical parts of the operation of the tournament in accordance with USBC Rule 303. Anything not covered in these rules will be governed by USBC rules. In her absence, the Association President will provide all oversight.
- 12. DRESS CODE: Participants must wear appropriate bowling attire. Shirts will have a "butterfly" type or "mock high neck" collar with sleeves, or be an official bowling Jersey. * NO T-SHIRTS, NO EXCEPTIONS.** Hemmed shorts (must extend beyond bowler's fingertips when standing relaxed and arms are extended downward at the bowler's side) and jeans (with no holes) will be allowed. **Prohibited attire includes,** but is not limited to, t-shirts, tank top shirts, cut offs, short shorts, headgear (allowed for medical reasons only), sweats or spandex leggings. Shirts with inappropriate or vulgar pictures or writing will not be allowed. See Rule 11 for any decisions required regarding questionable attire and all decisions will be final. Failure to comply means that bowler will not be allowed to bowl and cause forfeiture of entry fees.
- 13. CONDUCT:** It is our desire that everyone enjoy the facility and their experience here on Fort Huachuca, but an expectation of professionalism is expected to all employees, Service Members and their Families, and patrons that may be present outside of the tournament activity. Should discipline become an issue, entrants are not to receive any refunds, any pending scores will be given zeros, and Military Police will be engaging in all necessary activity.
